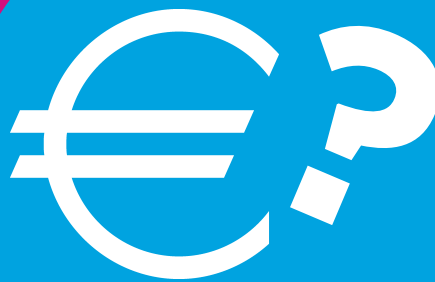

# FanTAXtic

## What does the competition entail?

Teams of 3 students in **transition year** (2018/2019) academic year must submit a 2-minute video giving their thoughts on a tax issue. This year we want to hear your thoughts on why **Tax is not only important for raising money!**

- 1** Explain how tax can be used as a tool to influence behaviour.
- 2** Why is this important?
- 3** Give one example of how the Irish Government have used tax to influence the behaviour of individuals.

## Competition Details

### How do I enter FanTAXtic Competition 2019?

- Gather a **team of 3** transition year students together (Note must be in the 2018/2019 academic year).
- Read up on the topic basing your research on the questions above.
- Create a **2-minute video** with all 3 students discussing your thoughts on the 3 questions above.

### How do I submit my team's entry?

- Once your team has completed this entry form and privacy policy, email them to [sobrien@taxinstitute.ie](mailto:sobrien@taxinstitute.ie) by 5pm Tuesday 16th April 2019.
- Your video must also be sent to us via Google Drive by 5pm on Tuesday 16th April 2019 (Please read all instructions carefully before you begin).

### What you need to know before making your video?

- Your video needs to be approximately **1.45 - 2 minutes** in length.
- All three students must be present in the video.
- The video will be an informal conversation on your thoughts on the question above.
- You don't need an expensive video recording device - use your mobile phone or a digital camera.
- When you have completed your entry, upload to Google Drive. See instructions for submitting a video to Google Drive opposite.



### What will the judges be looking for?

- Your team's understanding of the topic.
- Your team's ability to answer the 3 questions.
- Your team's creativity (your unique take on the topic).

### How do I submit our video to Google Drive?

- Open URL - <https://drive.google.com/drive/my-drive> and sign in using your Google account (you will need to create a Google account if you don't have one)
- Click on "New" on top left hand side and select File Upload.
- Browse to the location on your PC where the video file is located and click open to upload the file.
- Right Click the File and select Share.
- Enter the email address [sobrien@taxinstitute.ie](mailto:sobrien@taxinstitute.ie) and add your teams name in the text box.
- Hit the send button.
- On the next page select the option **Send the Link (no sign in required)**, and hit send.

### What are the prizes?

The Winning team will each receive a €200 One4All voucher.

The school of the winning team will receive a €500 cash prize.
